Photographer, Photographer's employees and/or legal representatives and successors and such other persons or entities as Photographer may authorize or designate shall be the exclusive author owner and copyright, proprietor of all of the results and proceeds relating to Photographer's use of the Property pursuant to this release. Without limiting the generality of the foregoing, Photographer shall own, throughout the world and perpetuity and may exploit in such manner, media and devices all photographs and matter photographed at, in, around and of the Property throughout the world in perpetuity, in all media now known or hereafter devised. Nothing contained in this release shall be construed as obligating Photographer to actually use the Property or produce or exploit the Images pursuant to this release. Unless otherwise permitted, Photographer, his legal representatives and successors agree Owner's personal identifying information (such as name) and/or geographical location, with exception to reference of general geographical information (such as country/state) will not appear in the Images, description/caption thereof or in any other information presented with the Images for licensing purposes.
